

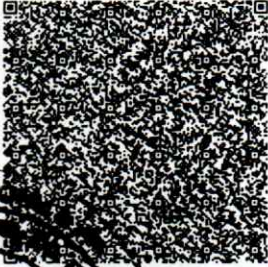



5. That the school will not open classes under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.


CERTIFICATE REGARDING SCHOOL STAFF
